## SCIENTIFIC TRIPS

AR23489679 "Formation of an effective system of local self-government in Kazakhstan: status, problems, solutions, innovations"

According to the approved schedule of the grant project on the topic: "Formation of an effective system of local self-government in Kazakhstan: state, problems, solutions, innovations" conducted research for a grant project on local self-government.

The research work was carried out in Almaty, Zhetysu and East Kazakhstan regions, covering two cities and nine rural settlements.

The purpose of this stage of the project was an in-depth analysis of the current state of local self-government. Special attention was paid to identifying problem areas and potential for development.

The working Group studied the state and problems of local self-government in the pilot regions of Kazakhstan, developed solutions and innovations for the formation of an effective system of local self-government in Kazakhstan. Studies were conducted in the following localities: Zhetysu region, Tekeli, Koksu district, Zharlyozek village, Mukanchi village, Boztogan village (from September 10 to September 16), Almaty region, Zhambyl district: Uzynagash village, Zhana-Kurylys village, Yntymak village; (from September 16 to September 22, 2024), East Kazakhstan region, Shemonaikha district: Shemonaikha, Lugovoye village, October village, Sadovoye village (from October 21 to October 27, 2024) through a survey of citizens. The data from the sociological survey was analyzed and an analytical report was prepared based on the results of the study, a draft Charter for pilot rural local governments and cities and a draft concept for the socio-economic development of pilot villages and cities were developed.









The members of the research group traveled to the Republic of Uzbekistan, Tashkent, to Tashkent State Law University and the Tashkent International University of Education (TIUE) from September 24, 2024 to September 27, 2024 to participate in an international round table on the topic: "Current problems of the development of local government and self-government the experience of Uzbekistan and Kazakhstan" and "Constitutional and legal foundations of modernization of society and the state in the Republic of Uzbekistan".

The project participants took an active part in the work of the international round table on the topic "Actual problems of the development of local government and self-government: the experience of Uzbekistan and Kazakhstan", which was held at Tashkent State Law University and the International University "Tashkent

International University of Education" (TIUE). The round tables discussed key issues of reforming and improving local governance systems in both countries, as well as ways to share best practices. The members of the research group presented reports on the current state and problems of the development of the local government system in Kazakhstan in the context of the grant project.

A constructive dialogue took place with Uzbek colleagues and international experts. Of particular interest was the comparative analysis of the legal foundations, functioning mechanisms and prospects for the development of local government and self-government in Kazakhstan and Uzbekistan.

This business trip was an important step in strengthening international relations, exchanging academic experience, and deepening comparative analysis of local government systems in the Central Asian region.

## Conclusions:

- 1. The business trip was successful, having fully realized the goals set.
- 2. Participation in the international round table made it possible to present the research results of Kunaev University on an international platform, receive valuable feedback and deepen understanding of problems and solutions in the field of local self-government in a regional context.
- 3. The materials obtained during the discussions and exchange of experience will be used in further work on the grant project, in particular, in developing proposals for the creation of real local governments in pilot settlements of Kazakhstan.
- 4. It is recommended to continue developing cooperation with Tashkent State Law University on issues of local government and self-government, including joint scientific publications, conferences and round tables.
